Total price (including any shipping fee) is \$ _____, and is the sole responsibility of the buyer, as well as the AKC (American Kennel Club) registration fees.

Be advised we will no longer hold puppies without a deposit. Deposits must be received within 3-5 business days or puppy will be re-sold. Once a deposit is received, deposit will not be moved to another puppy. Deposit to hold puppy is non-refundable. All payments must be in the form of cash, money order, or Paypal. A 3% fee will be charged for Paypal payment. This is due to Paypal charging seller 3-½ percent for transaction.

Puppies MAY be shipped after 8 weeks of age, but it is at the Seller's discretion not to ship until the puppy is appropriately healthy, strong, and at least 2 pounds.

High Class Shih Tzu guarantees puppy for 10 days from the date of sale against the following diseases: Parvovirus, Distemper, Leptospirosis, Hepatitis, Parainfluenza and Corona Virus. In the event that any of the above-stated diseases are diagnosed within the 10 day period, the seller is to be notified within 24 hours. A license veterinarian verifying the diagnosis with lab results must be provided within 3 business days after said diagnosis. Once seller has received confirmation of the submitted diagnosis, seller will accept immediate return of the puppy and refund the purchase price.

High Class Shih Tzu guarantees the puppy to be healthy at the time of purchase and current on all vaccinations and worming. In addition, High Class Shih Tzu also guarantees puppy to be free of genetic defects that are detrimental to the puppy's health for one (1) year from the puppy's date of birth.

In the event that a genetic defect is found by a licensed Veterinarian within the warranty period, **High Class Shih Tzu** will replace the puppy with another puppy of equal value upon receipt of a letter confirming diagnosis by a licensed Veterinarian and the return of the original puppy. Any upgrade, if you want any other puppy, must be paid by the buyer. **High Class Shih Tzu** cannot predict a time frame when a replacement puppy will be made available but will work with buyer to replace puppy in an agreeable amount of time.

Any puppy which buyer has purchased from **High Class Shih Tzu** must be seen by a licensed Veterinarian within 3 days of purchase by a Veterinarian of his/her choice. If purchased puppy is not seen within 3 days, this contract is null and void. **High Class Shih Tzu** is not responsible for vet charges of any kind once buyer has taken possession of puppy.

Umbilical hernias, open fontanels (soft spots on the skull), and pinches nostrils are very common in the Shih Tzu breed and are not a genetic hereditary or life threatening condition, therefore not bound by this contract. Slightly pinched nostrils are common in this breed and normally correct themselves as the puppy matures. This health guarantee does not include stress-induced illnesses such as hypoglycemia, worms, kennel cough, and coccidia.

All warranties are void in the event that buyer neglects to have puppy properly vaccinated by a licensed Veterinarian, or in any way harms, neglects, or fails to give proper medical attention. **High Class Shih Tzu** is not responsible for any Veterinarian bills of any type/kind after puppy has left the premises of seller.

While no refund will be given, **High Class Shih Tzu** is willing to take back puppy at any time if the buyer is unable to keep puppy due to any circumstances.

No guarantee is made in regard to size and color. Any estimates given are based solely on breeder's experience. No other guarantee is made or implied, except as stated in this written guarantee. Warranty applies to the original buyer only and is not transferable.
